## Parking Control Bye-Laws, 2025

---

Galway City Council in exercise of the powers conferred upon them by Sections 4(2) and 36 respectively of the Road Traffic Act, 1994, (No. 7 of 1994) and Section 101 of the Road Traffic Act 1961 as amended and Section 65 of the Local Government Act 2001, and having consulted with the Commissioner of An Garda Síochána, hereby make the following Bye-Laws in relation to the control and regulation of the parking of vehicles in the administrative area of Galway City.

| <b>Interpretation:</b>      | <b>4</b> | In these Bye-Laws:<br>“ <b>Galway City Council</b> ” means Council of the City of Galway and is hereinafter referred to as “The Council”. |

“**The Roads Traffic Acts**” mean the Road Traffic Acts, 1961 to 2024 any Act amending, extending, consolidating or re-enacting those Acts from time to time,

“**The Signs Regulations**” means the Road Traffic (Signs) Regulations 2024 (S.1. No. 200 of 2024) and any statutory instrument amending, replacing, consolidating or re-enacting those regulations from time to time.

“**The National Regulations**” means all regulations made pursuant to The Roads Traffic Acts and any statutory instrument amending, replacing, consolidating or re-enacting those regulations from time to time.

“**agent of the Council**” means any person employed by Galway City Council or any other person authorised by the Council to carry out functions under these Bye-Laws;

“**appropriate fee**” means the fee, prescribed in these Bye-Laws, for the parking area in which the vehicle is parked,

“**appropriate pay & display parking ticket machine**” means a pay and display parking ticket machine located on the public road or car park in which the vehicle is parked or on an adjacent public road,

“**acceptable evidence**” means the following: -

- a) a current insurance certificate which indicates that the vehicle in respect of which the resident’s parking permit has been applied for is normally kept at the resident’s address in the residential parking permit area to which the permit relates;

- b) where the applicant is the owner of the vehicle in respect of which the application for a resident's parking permit is being made and the vehicle is insured by his/her employer, the employer's insurance certificate and satisfactory documentary evidence from the employer that the applicant is in full time employment of the company and that the specified vehicle is insured by the company, or
- c) where the applicant is not the registered owner of the vehicle in respect of which the application for a resident's parking permit is being made, but has the use of the vehicle in the course of his or her employment, the employer's insurance certificate for the vehicle and satisfactory documentary evidence from the employer, who is registered owner of the vehicle, that the applicant is in the full time employment of the registered owner and that the vehicle is normally kept by the applicant at the resident's address in the resident's parking permit zone to which the permit will relate, and
- d) except in the case of paragraph (c) of this Bye-Law, a vehicle licensing certificate, registration book confirming that the resident applying for a resident's parking permit is the registered owner of the vehicle in respect of which the application for a resident's parking permit is being made and that the vehicle is registered at the residents's address in the residential parking permit zone to which the permit will relate and
- e) a driving or provisional licence in the name of the resident applying for the resident's parking permit and
- f) current utility bills, financial statements, tenancy agreement or other documentation, acceptable to the Council, addressed to the resident at his/her address on the public road which relates to the parking permit;
- g) The Council may renew a resident's parking permit on submission of a completed application form and on payment of the appropriate fee without submission of 'acceptable evidence';
- h) At any stage prior to the expiry of a resident's parking permit the Council may request the person to whom a permit was issued to produce 'acceptable evidence' to satisfy the Council that they were entitled to be issued with the permit. Any such request will be made in writing to the person to whom the permit was issued at the address given by that person on the application form;
- i) In the event of 'acceptable evidence' not being produced to the Council within one month from the date of the written request the Council may, at its discretion, deem the resident's parking permit to be invalid and cancel the permit without further notice.

**“authorised person”** has the meaning assigned to it by Section 103 (8) (inserted by the Road Traffic Act 1968) (No 25 of 1968) of the Road Traffic Act 1961.

**“buffer area”** means an area between two pay parking places;

**“carpark”** means an area which comprises an area for the parking of mechanically propelled vehicles by virtue of having marked bays suitable for parking of vehicles designated for parking of which the Council is the registered owner or in which the Council has a legal, proprietary or equitable interest.

**“carer”** means a person who is providing care to a Resident who requires on-going daily care of a chronic illness.

**“carer's parking permit”** means a document issued by the City Council which fulfils the purpose of Bye-Laws Nos. 28, 29, 30 & 31 containing particulars specified in Section 28 (1) to 28 (9), 29, 30 & 31 of these Bye-Laws.

**“disabled persons parking bay”** means a space on a public road or car park intended for the parking of a vehicle the driver of which or a passenger in which is disabled and so indicated by sign RRM 015 or by ground or other markings or signs.

**“disabled persons parking permit”** means a Parking Permit for a person with a disability issued by the Irish Wheelchair Association or the Disabled Drivers Association. A permit issued by state authorities is also recognised.

**“electric vehicle”** means a vehicle that is powered solely by means of a re-chargeable battery or by means of a re-chargeable battery and an internal combustion.

**“electric vehicle parking bay”** means a parking bay provided for the sole purpose of charging electric vehicles.

**“goods Vehicle”** means a vehicle used exclusively for carrying goods and taxed for commercial purposes.

**“house”** has the meaning assigned to it in the Planning and Development Regulations, 2001

**“information plate”** means a plate accompanying a traffic sign which indicates the period during which the restrictions or prohibition indicated by such traffic sign applies;

**“loading Bay”** has the meaning assigned to it in article 42 of the National Regulations and is indicated by means of traffic sign No. RRM 009 of the Signs Regulations accompanied by an information plate.

**“operational hours”** means the periods 8.30 hours to 18.30 hours from Monday to Saturday inclusive except where otherwise indicated on:

- (1) An information plate accompanying traffic sign number RUS 018 authorised by the Signs Regulations in the ticket parking area where the vehicle is parked or
- (2) The appropriate pay and display parking ticket machine located on the public road in which the vehicle is parked or on an adjacent public road,

**“owner”** means a resident by whom a vehicle is habitually kept and used;

**“parking bay”** means a space on a public road or car park intended for the parking of one vehicle and so indicated by ground or other markings or signs.

**“parking permit”** means a resident’s parking permit, visitors or carers parking permit issued by the Council or its agents for the purposes of Bye-Laws Nos. 21 to 30 and containing the particulars specified in Bye-Laws No.21 and 29;

**“parking permit area”** means a parking area on a public road or car park intended for the parking of vehicles and so indicated by ground or other markings or signs.

**“parking place”** means a place on a public road or carpark which is a ticket parking place,

**“Pay and Display Parking Ticket”** means a parking ticket which is issued by the Council by means of a pay and display parking ticket machine and which contains the following particulars:

- (a) The words “Comhairle Cathrach Na Gaillimhe” and/or ‘Galway City Council’
- (b) The fee paid in respect of the ticket,
- (c) The date and time of issue of the ticket,
- (d) The time of expiry of the ticket.

**“Pay and Display Parking Ticket Machine”** means a machine capable of automatically delivering a pay and display parking ticket when the appropriate parking fee prescribed by these bye-laws is paid.

**“permit database”** means the electronic database maintained by Galway City Council for the purpose of recording particulars of resident and carers parking permits; a vehicle shall be deemed to have a valid permit where its registration number is recorded in the permit database.

**“public road”** has the meaning assigned to it in Section 2(1) of the Road Traffic Act, 1993,

**“release fee”** means the fee, prescribed in these bye-laws, for the release of a vehicle that has been clamped by an Agent of the Council or any other Authorised Person,



**“Resident”** means a person who satisfies the Council that his/her normal residence is at premises situated in a street in a residential parking permit zone;

**“temporary dwellings”** means any tent, caravan, mobile home, vehicle or other structure or thing (whether on wheels or not) which is capable of being moved from one place to another (whether by towing, transport on a vehicle or trailer, or otherwise), and  
(a) is used for human habitation, either permanently or from time to time, or  
(b) was designated, constructed or adapted for such use.

**“Ticket Parking Place”** means a place on a public road or a car park where traffic sign or signs No. RRM 011, RRM 012, RRM 013, RRM 014, No.RRM 016 and/or RUS 018 authorised by the Signs Regulations of 1997 together with an accompanying information plate(s) indicates or indicate that parking of vehicles is subject to the exhibition of a Valid Pay and Display Parking Ticket.

**“traffic warden”** has the meaning assigned to it by Section 2 of the Local Authorities (Traffic Wardens) Act, 1975, as amended;

**“valid coins”** means, the coins indicated on the appropriate pay and display parking ticket machine,

**“valid eTicket”** means an electronic or physical receipt confirming payment for a parking period:-

- a) which has been registered, either
  - a. via a software program or set of software components designed for operation on mobile devices, including but not limited to smartphones, tablets, smartwatches, and other portable computing devices (an “app”), which has been designated by Galway City Council for use as official Galway City parking app; or
  - b. via a website provided by Galway City Council for purposes including the payment of appropriate fees; or
  - c. via such company as may be engaged by Galway City Council for the purposes of collecting and registering payments for parking in parking places); or
  - d. by way of calling Galway City Council's designated parking phone number; or
  - e. or by any other means that may be provided by Galway City Council from time to time; and

- b) for which the motorist has confirmed the vehicle registration number of the parked vehicle in question; and
- c) for which the motorist has confirmed the location in which the vehicle is being parked; and
- d) for which the motorist has received confirmation of payment from the system; and
- e) where the motorist has registered that the vehicle is parked for a period not exceeding the permitted duration in a ticket parking place in accordance with these Bye-Laws; and
- f) for the duration of the time the vehicle remains parked in the ticket parking place during operational hours.

**“valid disabled persons parking permit”** means such a parking permit which has not expired,

**“valid Flexible Stay Ticket”** means an entitlement issued by or on behalf of Galway City Council permitting the parking of a specified vehicle in a specified car park for a fixed period of time, which—

- (a) has been purchased in such manner as may be provided by Galway City Council from time to time for that purpose;
- (b) records the correct vehicle registration number of the vehicle in respect of which the entitlement is purchased;
- (c) authorises that vehicle, during the period of validity, to be parked on any number of occasions in the carpark specified in the said Flexible Stay Ticket, provided that such vehicle is not parked in contravention of any other provision of these Bye-Laws; and
- (d) is valid only for the carpark specified at the time of purchase and is not valid for on-street parking or for any other carpark.

**“valid Pay and Display Parking Ticket”** means a pay and display parking ticket which was purchased at an appropriate pay and display parking ticket machine for the period of parking permitted and has not expired.

**“valid Resident’s Parking Permit”** means a resident’s parking permit which relates to a particular residential parking permit zone or zones and to a period which has not expired and which is issued by Galway City Council in whose functional area the vehicle on which the permit is displayed is parked;

**“vehicle”** means a private motor car, a station wagon or a passenger vehicle having accommodation for not more than seven passengers excluding the driver;

**“visitor”** means one who visits, calls on, or makes a stay with the resident or is engaged by the resident to carry out works on the dwelling;

**“visitor parking permit”** means a visitor-parking permit issued by the City Council, its agents or authorised officers only containing the particulars in Bye-Law No. 32.

A reference in these bye-laws to a traffic sign means a reference to a traffic sign prescribed in the Road Traffic (Signs) Regulations 1997 (S.I. No. 181 of 1997) and any number referred to in association with a traffic sign shall be the number allocated to such sign in such regulations.

A reference in these bye-laws to an information plate accompanying a traffic sign shall, unless otherwise specified, be to an information plate which shall indicate the period (which shall include the days and hours) when the allowance, restriction or prohibition indicated by such traffic sign applies.

- (a) In these bye-laws any reference to an article or a schedule, which is not otherwise identified, is a reference to an article of, or a schedule to these bye-laws.
- (b) In these bye-laws, any reference to a sub-article, paragraph, or sub-paragraph which is not otherwise identified, is a reference to the sub-article, paragraph or sub-paragraph of the provision in which the reference occurs.
- (c) In these bye-laws a reference to any enactment shall be construed as a reference to that enactment as adapted by any subsequent enactment or instrument.
- (d) A reference in these bye-laws to the loading of goods shall be taken to include the supplying of fuel for the operation of the vehicle.

**Repeals:**

- 5 Subject to Bye-Law 43, the Galway City Council Pay and Display Street Parking Bye-Laws 2004, the Galway City Council Pay and Display Street Parking (Amendment No.2) Bye-Laws 2008, the Galway City Council Pay and Display Street Parking (Amendment) Bye-Laws 2009, Galway City Council Parking Control Bye Laws 2009 and Car Park Bye-Laws 2005 are hereby revoked (in so far as same may still be operative) and replaced by Galway City Council Parking Control Bye Laws 2025.

| <b>Parking in Pay and Display ticket parking places</b>                 | <b>6</b> | <p>The following provisions shall apply during operational hours to parking of a vehicle in a ticket parking place: -</p> <ul style="list-style-type: none"><li>(a) subject to Bye-Law 12, a vehicle which is parked in a ticket parking place during operational hours shall, where parking bays are provided at that ticket parking place, be parked within the area comprising a parking bay;</li><li>(b) a person shall not park or cause to be parked in a ticket parking place a vehicle in such a position that it, or any portion of it, extends from one parking bay to another;</li><li>(c) a person shall not use a ticket parking place for any purpose other than parking a vehicle except with the prior written approval of a Director of Services of Galway City Council, and according to all terms as specified by the Director of Services.</li></ul>   |
| <b>Vehicles which may be parked in Pay &amp; Display parking places</b> | <b>7</b> | <p>Mechanically propelled vehicles only, of the following classes may be parked in a ticket parking place during operational hours:-</p> <ul style="list-style-type: none"><li>(a) a passenger vehicle with passenger accommodation for not more than eight persons excluding the driver and not drawing a trailer or other vehicle,</li><li>(b) a goods vehicle whose unladen weight does not exceed 3.5 tonnes and not drawing a trailer or other vehicle;</li></ul>   |
| <b>Obligation to display valid Pay and Display Parking Ticket</b>       | <b>8</b> | <p>Where a vehicle is parked in a ticket parking place on a day and during the hours specified on an information plate accompanying traffic sign or signs No. RRM 011, RRM 012, RRM 013, RRM 014, No. RRM 016 and/or No. RUS 018 authorised by the Signs Regulations:</p> <p><b>(1)</b></p> <ul style="list-style-type: none"><li>(a) a valid pay and display parking ticket, parking permit, or disabled parking permit shall be displayed.</li><li>(b) The valid pay and display parking ticket, parking permit, or disabled parking permit shall be so displayed in the interior of the vehicle in respect of which it is issued that it can be easily read from outside the vehicle,</li><li>(c) The valid pay and display parking ticket, parking permit, or disabled parking permit shall be exhibited in accordance with paragraph (b) of this bye-law for so long as the vehicle is parked in that ticket parking place.</li></ul> |

- (d) Where a pay and display parking ticket has expired by over 30 minutes and not exceeding 1 hour, a vehicle may be clamped and a release fee as outlined in Appendix III of these Bye Laws will apply.
  - (e) Where a pay and display parking ticket has expired by over 1 hour, a vehicle may be clamped and a release fee as indicated in Appendix III of these Bye Laws will apply.
  - (f) Where no pay and display parking ticket is displayed, a vehicle may be clamped after 10 minutes and a release fee as indicated in Appendix III of these Bye Laws will apply.
  - (g) Where parking is prohibited, a vehicle may be clamped immediately and a release fee as indicated in Appendix III of these Bye Laws will apply.
- (2)** Where a vehicle being parked in a ticket parking place on a day and during the hours specified on an information plate accompanying traffic signs or signs No. RRM 011, RRM 012, RRM 013, RRM 014, No. RRM 016 and/or No. RUS 018 authorised by the Signs Regulations is a goods vehicle being so parked solely for the loading and unloading of goods, paragraph (1) of this Bye-law shall not apply until after the expiration of 20 minutes from the time of the vehicle entering the parking place and the commencement of parking therein.
- (3)** Where a vehicle which has been parked in a ticket parking place for a period less than the maximum parking period in accordance with Bye-law 9 of these Bye-laws for that ticket parking area is subsequently lawfully parked in another ticket parking area on the same day, it shall not be necessary, subject to compliance with paragraph 1(a), 1(b) and 1(c) of this bye-law, to purchase an additional pay and display parking ticket.
- (4)** Bye-Law 8(1) shall not apply where the motorist has procured either:-
- (a) a valid eTicket, as defined in Bye-Law 4, for the period during which the vehicle is parked in the relevant ticket parking place, provided that the eTicket corresponds with the vehicle registration number of vehicle so parked and remains valid for the duration of such parking.
  - (b) a valid Flexible Stay Ticket, as defined in Bye-Law 4, in respect of the vehicle parked in the relevant carpark specified in the said ticket, provided that the ticket remains valid for the period of parking and that the vehicle is parked in compliance with the conditions applicable to that ticket.

<b>Period of parking in ticket parking place</b>	<b>9</b>	<p>(1) A vehicle parked in a ticket-parking place on a day and during the hours indicated on an information plate accompanying traffic sign or signs No. RRM 011, RRM 012, RRM 013, RRM 014, No. RRM 016 and/or No. RUS 018 authorised by the Signs Regulations shall not be so parked for longer than the period indicated as the maximum period for that ticket-parking place indicated on such information plate.</p> <p>(2) Where a vehicle which has been lawfully parked in a ticket parking place is subsequently lawfully parked in another ticket parking place the period to which the subsequent parking is restricted by paragraph (1) of this bye-law shall be reduced by a period equal to the period from the time indicated on the ticket to the time when the subsequent parking commenced.</p>
<b>Removal of vehicle from ticket parking place</b>	<b>10</b>	<p>(1) A vehicle parked in a ticket parking place at a time outside the time specified for payment of parking on an information plate accompanying traffic signs No. RRM 011, RRM 012, RRM 013, RRM 014, No. RRM 016 and/or No. RUS 018 authorised by the Signs Regulations may be clamped or removed from the ticket parking place when a period of hours specified on such information plate commences, unless at such commencement and during the remainder of the period of parking, the motorist who parked the vehicle has either procured a valid eTicket or a valid pay and display parking ticket is exhibited in the interior of the vehicle in accordance with Bye Law 8(1)(b) and Bye Law 8(1)(c) of these Bye-Laws.</p> <p>(2) Any vehicle parked in a ticket parking place in contravention of any provision of these Bye-Laws may be clamped or towed away by the Council or its agents. Clamped vehicles will be released on payment of the appropriate fee. Vehicles towed away and removed to storage by the Council or its agents will be disposed of as detailed in Section 10(3).</p> <p>(2A) Without prejudice to Bye-Law 10(2), where a vehicle is parked in contravention of these Bye-Laws, or of the Road Traffic Acts or the National Regulations, the Council or its agents may tow the vehicle from the place where it is parked and relocate it to another public place, where it may lawfully be parked, and the Council shall be entitled to recover from the registered owner of the vehicle the reasonable costs of such towing and relocation.</p> <p>(2B) The Council may, in addition to or instead of relocation pursuant to Bye-Law 10(2A), remove a vehicle to storage in accordance with Bye-Law 10(2).</p>

		<p>(3) If ownership of a vehicle removed by the Council from the ticket parking place pursuant to Bye-Law No.10 (2) is not claimed, proved and the removal and storage charges paid within fourteen days of the date of the removal of the vehicle from the ticket parking place, the Council shall notify the owner of the vehicle (in so far as his/her identity can be ascertained) by post or a notice published in a local newspaper of its intention to dispose of the vehicle.</p> <p>(4) The Council shall dispose of a vehicle the subject of a Notice under Bye-Law No. 10(3) in whatever manner it considers appropriate and the proceeds of such disposal shall be retained by the Council for use in the discharge of any of its functions.</p>
<b>Prohibition on certain parking inside an hour of leaving ticket parking place</b>	<b>11</b>	A vehicle, which had been parked in a ticket parking place, shall not be parked again in a ticket parking place in the public road in which that ticket parking place is situated until at least one hour after vehicle last vacated that ticket parking place.
<b>Issue of Pay and Display Parking Tickets</b>	<b>12</b>	<p>(1) A pay and display parking ticket shall be purchased from an appropriate pay and display parking ticket machine.</p> <p>(2) The fee for the pay and display parking ticket shall be payable by means of any combination of valid coins or by Debit or Credit Card.</p> <p>(3) Payment shall be made by inserting the appropriate fee for the parking time required into the appropriate parking ticket machine and following the instructions on the parking ticket machine in order to obtain a valid pay and display parking ticket.</p> <p>(4) The valid parking ticket shall be displayed immediately on parking provided that, where a vehicle is parked at a time not during operational hours, the valid parking ticket shall be displayed in accordance with bye-law 8 at the commencement of operational hours.</p> <p>(5) As an alternative to procuring a pay and display ticket, a motorist parking a vehicle in a ticket parking place may procure a valid eTicket or, where applicable, a valid Flexible Stay Ticket.</p>
<b>Fee for Pay and Display Parking Tickets</b>	<b>13</b>	The fee for a pay and display parking ticket shall be as indicated in Appendix 1 of these Bye Laws and are shown on the appropriate parking ticket machine.
<b>Conditions for parking in a ticket parking places</b>	<b>14</b>	<p>(1) A vehicle which is parked in a ticket parking place on a day and during the hours indicated on an information plate accompanying traffic sign or signs No. RRM 011, RRM 012, RRM 013, RRM 014, No. RRM 016 and/or No. RUS 018 authorised by the Signs Regulations shall, where parking bays are provided at that ticket</p>

parking place, be parked within the area comprising a parking bay.

- (2) A vehicle shall not be parked in a buffer area,
- (3) A ticket parking place may not be used for overnight accommodation purposes whether by camper van, caravan, van, car or otherwise,
- (4) Buses and coaches with a seating capacity in excess of eight passengers excluding the driver are prohibited from parking in a ticket parking place except where designated parking spaces are provided for such use and any appropriate fee paid.
- (5) A person shall not overhaul or carry out mechanical works or repairs to a vehicle whilst it is parked in a ticket parking place, save for where it is necessary in order to enable the vehicle to be removed from the ticket parking place,
- (6) A vehicle, while parked in a ticket parking place, shall not be used for the sale of goods in or from the vehicle or as an office; nor shall any such vehicle be offered or displayed for sale or for hire or as a prize. A person shall not make any unnecessary noise by means of, or in relation to, a vehicle while it is parked in a ticket parking place, or by means of any equipment, fitting or instruments fitted to or carried on the vehicle or any loud speaker or radio in anyway connected to the vehicle.
- (7) A vehicle shall not be parked in a carpark or any ticket parking place in a manner which causes or is likely in the opinion of a Traffic Warden or an authorised person to cause damage to persons using the carpark or ticket parking place or in the opinion of a Traffic Warden or an authorised person obstructs the entrance to or exit from a carpark or ticket parking place or the free flow of traffic within a carpark or ticket parking place and any such vehicle may be removed by the Council in accordance with Bye-Law 10 herein.
- (8) A vehicle shall not be driven within a carpark in excess of a speed of fifteen kilometres per hour.
- (9) A vehicle shall not be driven in a carpark contrary to the flow of traffic in the carpark indicated by ground or other markings or signs.

**Prohibition on parking of Temporary dwellings**

**15**

- (a) A camper van, caravan, mobile home or vehicle otherwise used for accommodation purposes shall not be parked overnight in a public carpark within the administrative area of Galway City.

  - 1. The Renewal of a parking permit shall be the sole responsibility of the holder of a parking permit.
  - 2. The residents' parking permit must be renewed within the renewal period, which ends 28 days after the expiry date of the existing permit. Where a permit is not renewed within the renewal period, the holder of an expired permit shall, on subsequent application for a resident's parking permit for that address, be considered as a first time applicant under these Bye-Laws and a permit shall not issue unless the applicant is eligible for a permit under these Bye-Laws at the time of the subsequent application.

**Return and transfer of parking permit**

**26**

- (1) Where during the period to which a resident's parking permit relates, the resident to whom it is issued ceases to reside at the address specified on the permit or ceases to be an owner of the vehicle to which the permit relates, shall return it (if it is a physical permit) to the Council. A resident parking permit is non-transferable and any physical permit issued remains the property of the Council from the date of issue.
- (2) Where during the period to which a resident's parking permit relates, the resident to whom it is issued replaces the vehicle to which the permit relates, shall return the permit (if a physical permit) to the Council which upon payment of the fee as indicated in Appendix II shall issue to the resident, subject to production of acceptable evidence in respect of the new vehicle, a new permit in respect of the vehicle, and such new permit shall be valid for the period specified.

**Change of Address- issue of Resident's parking permit**

**27**

If the holder of a resident's parking permit granted under these Bye-Laws changes address, either within a residential parking permit area or from one residential parking permit area to another, the Council or its agents may, following surrender of the original permit (if a

physical permit) and production of acceptable evidence, issue a resident's parking permit in respect of the new address, provided that the permit holder would otherwise qualify for a resident's permit at the new address under these Bye-Laws. A permit issued under this Bye-Law shall be valid for the remainder of the period specified in the original permit. If the original permit (if physical) is not surrendered, a fee as indicated in Appendix II shall apply to the issue of the new resident's parking permit. No financial adjustment, credit or refund shall be granted in respect of the difference in price between the categories of permit charges.

**Issue of and fee for resident's parking permit to non-resident family member(s)/nominated person(s)/Carers**

**28**

- (1)** A resident's parking permit may be issued by the Council to a non-resident family member(s)/nominated person(s) or carer who act as voluntary carers for a resident in a ticket parking place and who requires on-going daily care for a chronic illness.
- (2)** A parking permit shall be issued annually to a qualified resident subject to the submission of proof of residency, submission by a non-resident family member(s) or carer's vehicle insurance certificate and written confirmation from the resident's doctor that the resident requires ongoing daily care for a chronic illness
- (3)** A non-resident family member(s)/nominated person(s)/carer's parking permit shall be valid for a period of one year from the date of issue. A maximum of 2 permits may be issued to a qualifying Resident. The fee for the issue of a non-resident family member(s)/nominated person(s)/carer's parking permit(s) shall be as indicated in Appendix II of these Bye Laws.
- (4)** A non-resident family member(s)/nominated person(s)/carer's parking permit may be issued by the Council to a Resident who requires care in accordance with Bye-Law 28 (1) of these Bye-Laws and who resides at premises situated in a pay and display ticket parking place. The non-resident family member(s)/nominated person(s)/carer's parking permit shall be issued in respect of the residential parking permit area(s) in which the normal place of residence of the person requiring care is situated and one other such adjacent zone, as the case may be.
- (5)** A non-resident family member(s)/nominated person(s)/carer's parking permit shall be used by the Council in respect of:
  - a motor car,
  - a van,
  - a passenger vehicle (having accommodation for not more than eight passengers excluding the driver).
